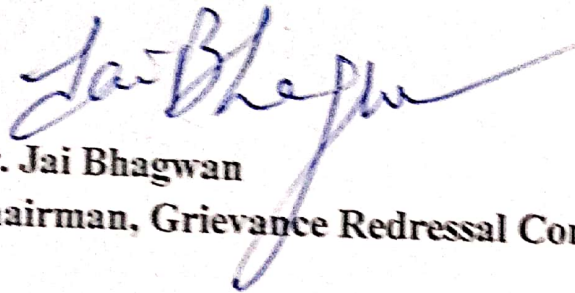
4. To submit report regarding Effectiveness of GRC and Student's Satisfaction

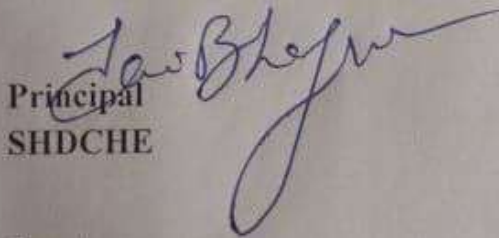

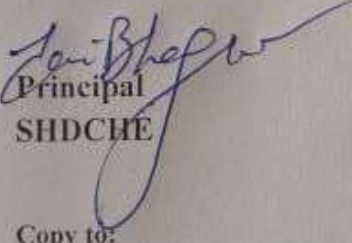
